Objective of the Event

The Education Department of the Government of Gujarat introduced the Student Startup and Innovation Policy, aiming to foster innovation and pre-incubation processes statewide. Sarvajanik University (SU) entered into a Memorandum of Understanding (MoU) with the Gujarat Knowledge Society (GKS), the policy's central implementation nodal agency. As part of the policy, Sarvajanik University has been granted the Student Innovation Fund (SIF) for 4 years, spanning from 2023 to 2027, by the Government of Gujarat, under the Student Startup and Innovation Policy 2.0. Following is the breakup of SIF and GMF agreed upon in the MOU signed on 5 July 2023

Event in Brief:

- SU-level Idea Pitching Event 2025 was conducted in two stages: Institute Level and University Level. Institute coordinators identified the most promising ideas, and those teams or individuals represented their institutes in the University round
- A total of 14 teams/individuals registered for the SU-level event, and 13 of them fully (Remaining present for each time they were called) presented their ideas in two groups. One group was reviewed by Dr. Anil Saraogi and Mr. Bihag Trivedi, alongside coordinator Dr. Ranjan Sabhaya, while the other group was evaluated by Mr. Chetan Patel and Advocate Viken D. Shah with Dr. Jayshree Siddhpuria as the coordinator.
- Amongst these groups, 5 ideas were accepted for both IPR (Intellectual Property Rights) support and POC & all these funding have been approved through the advisory committee meeting conducted on 5th March, 2025.
- On 29th January, 2025 certificates distribution ceremony was held to all recipients, participants, volunteers, co-ordinators & Mentors of teams.
